### Consultation on the draft Melton Road Edwalton Development Framework Supplementary Planning Document

The Borough Council has produced the above draft Supplementary Planning Document (SPD) for consultation.

The SPD will supplement the Rushcliffe Local Plan Part 1: Core Strategy, which allocates land at Melton Road, Edwalton for development, including for around 1,500 new homes. The purpose of the SPD is to provide guidance for the preparation and determination of planning applications on this land. One of its key roles is to identify detailed infrastructure requirements in order to ensure that new facilities are provided in a co-ordinated manner.
